### TERMS OF SALE

1. Kittens that are sold as pet-only or for show are altered before they leave our home so as to prevent unnecessary breeding. The cost of the alter IS included in the purchase price of the kitten. Buyer will be provided with the kitten's registration papers at the time kitten is picked up.  
**Kittens sold with breeding rights** are sold only to credible breeders with a registered cattery. Prior to the sale of the kitten, Buyer must provide a copy of the 3-year pedigree for each breeding Ragdoll that they already own. If Buyer does not already own a breeding Ragdoll at the time of sale, another breeding Ragdoll must be purchased from a breeder that is pre-approved by us (we will give referrals)! Buyer must also agree to show the cat in at least one cat show by 1 year of age.
2. This kitten is guaranteed to be healthy when it leaves our home. **Buyer has 72 hours to bring the kitten to a licensed veterinarian**, at his/her own expense, for a complete examination. If the kitten is found to have any health issues that originated while in Breeder's possession, we will take the kitten back and provide a full refund after being furnished with a letter from the vet indicating why the kitten's health is in question. Buyer must notify us of a problem within 72 hours of picking up the kitten in order to claim this warranty. Injuries/illnesses sustained after leaving the breeder's premises will not be covered by the breeder.  
**Keep in mind that new kittens may show signs of stress, including sneezing, runny nose, watery eyes, diarrhea, or constipation, when brought into a new environment.**
3. **This kitten has a 1-year guarantee against lethal genetic or congenital defects.** Upon being provided an autopsy report from a licensed veterinary pathologist stating the unquestionable genetic or congenital defect, the kitten will be replaced by the first available kitten of equal quality.

4. This kitten will have received two sets of shots (at 8 and 12 weeks) and will be dewormed by the time Buyer takes the kitten home. The kitten is vaccinated against Panleukopenia, Rhinotracheitis, Calcivirus, and Chlamydia. Shot records will be provided.
5. **This kitten is not allowed to receive FIP or FELV vaccinations**, as they are controversial and pose too many risks. In addition, these vaccines are unnecessary for indoor cats. **Our health guarantee will be void if the kitten is found to have received these vaccines.** Kittens should only be vaccinated with “killed-virus” or “modified-live-virus” vaccines, not “live-virus.”
6. **Under NO circumstances is this kitten to be declawed!** The kitten should already be accustomed to using a scratch post by the time it leaves our home. The kitten will also have been exposed to nail trimming, which we do weekly after 4 weeks of age.
7. **This kitten is never to be allowed outdoors.** Due to their non-aggressive behavior and inability to protect themselves sufficiently, Ragdolls are meant to be indoor cats.
8. **Under NO circumstances will this kitten be sold, leased, traded, or given to any pet shop, kitten mill, research lab, shelter, or anyone else.**
9. This kitten has known nothing but unconditional love. Buyer is responsible for providing this kitten with kindness, compassion, love, and proper attention, which includes quality cat food, fresh water daily, playful interaction (both with people and toys), a clean/sanitary litter box, and regular veterinary care.
10. If the buyer can no longer care for the kitten or wishes to give the kitten up for any reason (other than for health issues discussed above), the kitten **MUST** be returned to us without refund.
